## 2021-22 KPL TRAPPED PLAYER ROSTER FORM

The Kentucky Premier League permits the use of Over-aged or Trapped player during the Fall portion of a 14U's team schedule.

According to Section 12.8 of the official KPL Regulations, over age or trapped players are true U15 players who have not moved up to high school with their peers.

During the fall season months only (Aug-Nov), U14 teams may roster up to five (5) U15 over age/ trapped players. These players must be dropped from the roster by November 15th.

All over age/trapped players should appear on league rosters and be approved by KYSA and this approved from must be attached to the official Match report for each game. Trapped players must be dropped from the roster and transferred to their correct age group team before the team's roster is frozen for State Open Cup competition.

***This form must be filed with the KPL Front Office no later than two (2) business days prior to the first game a Trapped Player will participate in a KPL Match and provided to Match Officials before EVERY game in which the Trapped Player will participate.***
